# III. President- Ashley Spicer-Runnels

• Conference updates -Holmes & Perez-Carey reported they have been planning for conference and shared the theme: Influence & Impact: Strategies to Accelerate Systemic Change within the Profession and Beyond. Conference chairs would like to develop tracks for this conference. Board liked the theme and how it provides opportunities to discuss different topics. Perez-Carey reported that they are working on the selecting conference committee members and want to ensure that there is diverse representation from different institution types. Spicer-Runnels indicated that she would like to include people from community colleges and the Dallas area. Melendez, Spicer-Runnels, and Simpson provided suggestions and Holmes &



Perez-Carey will follow Student Personnel Administrators up on committee members. Holmes provided keynote speakers ideas. Names provided are Julie Winna, Adam Grant, Lori White, Chiquita Collins, Alicia Eggert, and Michele Singh. Lopez-Coronado suggested Jennifer Jones, Snow suggested Ainsley Carry, Simpson suggested Jerry Wallace. Holmes clarified that none of these people presented have been secured. Spicer-Runnels will send out a draft conference budget to Board. Conference rates were approved in San Marcos and those will be reflected in the draft conference budget. Spicer-Runnels will be adding a virtual ticket rate to the conference budget as well. Chairs working with Spicer-Runnels to establish a conference timeline to help determine when a decision will be made to make the conference totally virtual. Melendez suggested that a decision be made by March based on this last year's experiences with venue contracts.

- **February virtual retreat** Spicer-Runnels reported that February 15-19 is the popular week. She will go with that date that the majority of board has indicated. - TACUSPA@Work Spicer-Runnels added a page to TACUSPA website called Strategic Initiatives to capture what is being done. Spicer-Runnels has pulled together an advisory board to discuss curriculum to get feedback and to see if this is an initiative that will continue.

should identify a Student Personnel Administrators TACUSPA champion at each campus to help advocate for people to serve in volunteer roles. Spicer-Runnels and Folsom have been planning to do a PR type of outreach.
